## Scholarship Guidelines and Instructions

### ELIGIBILITY REQUIREMENTS

Applicants must meet the following criteria:

- Be an African-American high school senior who is a resident of Fairfax County, VA or Washington, DC.
- Demonstrate strong academic standing with a **minimum cumulative GPA of 3.0**.
- Graduate from an accredited secondary educational institution in Spring 2020.
- Plan to enter a four-year college or university as a full-time freshman in Fall 2020.
- Demonstrate community service experience.
- *NOTE: Children of members of Jack and Jill of America, Inc. are ineligible to apply.*

### HOW TO APPLY

Application submissions must include the following:

- A complete and signed Scholarship Application.
- A one-page typewritten personal essay (Times New Roman 12-point font, double-spaced).
- An original color photo (.jpg format preferred); alternatively, a 4x6 or wallet-size photo may be submitted. Do not submit proofs or personality photos.
- An official academic transcript with cumulative grade point average. The transcript must be submitted in an envelope sealed by a school official with the official's signature or the school stamp across the sealed portion of the envelope.
- A signed 2019-2020 letter of recommendation from a current teacher, school counselor, or principal submitted on school letterhead.

### APPLICATION DEADLINE AND SUBMISSION

The completed and signed application package must be submitted via email by 11:59 p.m. (Eastern) on OR postmarked by **April 7, 2020**. Incomplete submissions will not be considered. Applicants are responsible for ensuring their transcript and letter of recommendation are submitted on time. Do not send your application via certified mail or use a delivery service that requires the recipient's signature.
